

You are hereby notified that I have amended Provisional Certificate of Approval No. A 420010 issued on May 28, 1999 for a landfilling site, as follows:

- 1. Condition 14 of the Certificate of Approval dated May 28, 1999 is hereby revoked.
- 2. The following item is hereby added to Schedule A attached to the Certificate of Approval:
 - 8. Letter and attachments dated May 8, 2001 from Steven Testart, North Renfrew Waste Management Board to the Dave Staseff, Environmental Assessment and Approvals Branch.

The reasons for this amendment to the Certificate of Approval are as follow:

Condition 14 is being revoked because he documents noted in condition 14 have been received and accepted by the Director. They are hereby added to Schedule A of the Certificate of Approval as documents supporting to the approval.

This Notice shall constitute part of the approval issued under Provisional Certificate of Approval No.A 420010 dated May 28, 1999.

In accordance with Section 139 of the Environmental Protection Act, R.S.O. 1990, Chapter E-19, as amended, you may by written notice served upon me and the Environmental Appeal Board within 15 days after receipt of this Notice, require a hearing by the Board. Section 142 of the Environmental Protection Act, provides that the Notice requiring the hearing shall state:

- The portions of the approval or each term or condition in the approval in respect of which the hearing is required, and; 1.
- The grounds on which you intend to rely at the hearing in relation to each portion appealed. 2.

The Notice should also include:

3. The name of the appellant;

- 5. The Certificate of Approval number;
- 6. The date of the Certificate of Approval:
- 7. The name of the Director;
- 8. The municipality within which the waste disposal site is located;
